9. The bids will be opened electronically in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 2077/09/03 at the office of Mandavi Rural Municipality.

Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2,60,000.00 which shall be valid for 30 days beyond the validity period of the bid (atleast 90 days from bid opening date, fill it yourself).
